2024 BID SHEET FOR AERIAL TREE WORK

The Arenac County Road Commission is requesting bids for Aerial Tree Work. The work will consist of cutting trees and limbs from the County Road Right-of-Way (R.O.W.) above the road surfaces. Bidders are required to have an Aerial Bucket Truck and an operator.

- Road Commission will supply ground labors, chipper and traffic control for aerial tree work and clean-up.
- Minimum 4-hour day and 24-hour notice. We will not pay for travel time.
- Trees will be cut to ground level and limbs flush cut to the tree. All work will require an aerial bucket truck that can extend up to 30' from ground level.
- Contractor must provide all certifications for the aerial truck and operator.

Insurance requirements

The Arenac County Road Commission requires that a “**Certification of Insurance**” be on file prior to allowing work within the right-of-way of any road under the jurisdiction of the Road Commission.

The certificate of insurance shall contain or include the following:

1. Board of County Road Commissioners and Arenac County Road Commission and all employees named as addition insured to all coverage.
2. General liability coverage - \$1,000,000 each occurrence.
3. Automotive liability - \$1,000,000 each occurrence.
4. Worker’s compensation – statutory limits.
